I, Hanuman Mal Choraria, Practising Company Secretary, having C. P. No. 1499, have been appointed, by the Board of Directors of M/s. Rupa & Company Ltd ("the Company") as a Scrutinizer for the purpose of conducting the Postal Ballot process including voting through electronic means and to report in respect of seeking its members assent/ dissent for passing the Special Resolution, pursuant to the provisions of the Companies Act, 2013 and all other applicable laws, as stated in the Notice of Postal Ballot, dated March 11, 2016.

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and rules relating to Postal Ballot and voting through electronic means on the Resolution contained in the Notice dated March 11, 2016. My responsibility as Scrutinizer for Postal Ballot including e-voting process is restricted to make a Scrutinizer's Report of votes cast "In favour" or "Against" the resolution stated in the Notice of Postal Ballot, based on the postal ballot received by me and the report generated from e-voting system provided by the National Securities Depository Limited (NSDL), the authorized agency engaged by the Company to provide the e-voting facility. This e-voting report is generated on the basis of information available/ downloaded from the NSDL website:

Further to the above, I hereby submit my Report:

1.1 The Company has completed dispatch of notice of postal ballot, dated **March 11, 2016**, on **March 19, 2016** by sending e-mail to the members, whose e-mail address is registered with the Company and by **March 21, 2016** to the members whose e-mail address is not registered with the Company, along with the postal ballot forms with self addressed postage prepaid business reply envelopes to its Members whose names appeared on the Register of Members/ list of beneficiaries as on March 11, 2016 (the cut-off date) and who were entitled to vote on the Resolution set out in the notice mentioned herein above. The e-voting process remained open from (09.00 A.M) IST on Saturday, March 19, 2016 to Sunday, April 17, 2016 up to (05.00 P.M.) IST.



1.2 Particulars of all postal ballot forms received from the members and the votes cast by electronic mode have been entered in the register separately maintained for the purpose.

1.3. The postal ballot forms were kept under my safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.

1.4 The ballot boxes were opened on April 18, 2016 in my presence.

1.5 The postal ballot forms were duly scrutinized in my presence on April 18, 2016 and the shareholding was matched/ confirmed with the Register of Members of the company/ list of beneficiaries.

1.6 All postal ballot forms and e-voting received upto the close of working hours (5.00 PM) on April 17, 2016, the last date and time fixed by the company for receipt of the forms and e-voting, were considered for my scrutiny.
