3. The Hon'ble National Company Law Tribunal, has sanctioned a Scheme of Arrangement ("the Scheme") between the company and its wholly owned subsidiary, M/s Oban Fashions Pvt. Ltd. (OFPL) wherein the premium brand undertaking of OFPL shall be demerged and transferred to the Company having an appointed date of April 1, 2021. The Scheme became effective from January 17, 2022 upon completion of necessary formalities and had been accounted for under the 'pooling of interests' method in accordance with Appendix C of Ind AS 103 'Business Combinations' during the previous year ended March 31, 2022. Accordingly, figures for the corresponding quarter ended on June 30, 2021 presented in these financials results has been restated after considering all accounting impact pursuant to the aforesaid Scheme.

ii) The financial information/financial results of a subsidiary located outside India, included in the unaudited consolidated financial results, which constitute total revenue of Rs. Nil, net loss after tax of Rs. 0.05 lakhs and total comprehensive loss of Rs. 0.51 lakhs for the quarter ended June 30, 2022, have been prepared in accordance with accounting principles generally accepted in its country of incorporation and have not been reviewed by their auditor. The Company's management has converted the interim financial information / financial results of such subsidiary located outside India from the accounting principles generally accepted in its country to the accounting principles generally accepted in India.
