1. We have reviewed the accompanying statement of unaudited standalone financial results of **Rupa & Company Limited** ('the Company') for the quarter ended June 30, 2026 together with notes thereon (hereinafter referred to as 'the Statement'), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended ('the Listing Regulation').
2. This Statement, which is the responsibility of the Company's Management and approved by the Company's Board of Directors at their meeting held on August 10, 2026, has been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under section 133 of the Companies Act, 2013 as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India. 3. During the quarter, the Company has received dividend of Rs. 302.30 lakhs from one of its wholly owned subsidiary, which is currently not carrying on any business operations. Consequent to the payment of dividend, the net worth of the said subsidiary has significantly eroded. Accordingly, the Company reassessed the recoverable value of its investment in the said subsidiary and recognised an impairment loss of Rs. 144.14 lakhs during the quarter, which is disclosed as an exceptional item.

According to the information and explanations given to us by the management, these interim financial information / financial results are not material to the Group. Our conclusion on the Statement, in so far as it relates to the amounts and disclosures included in respect of the above subsidiaries, is based solely on the financial information / financial results certified by the management and the procedures performed by us as stated in paragraph 3 above.
- ii) The interim financial information / financial results of one subsidiary located outside India, included in the unaudited consolidated financial results, which reflects total assets of Rs. 9.35 lakhs and net assets of Rs. 7.91 lakhs as at June 30, 2026, total revenue of Rs. Nil, net loss after tax of Rs. 0.11 lakhs, total comprehensive loss of Rs. 0.03 lakhs for the quarter ended June 30, 2026 and net cash inflows of Rs. 0.04 lakhs for the quarter ended June 30, 2026, have been prepared in accordance with accounting principles generally accepted in its country of incorporation and have not been reviewed by their auditor. The Company's management has converted the interim financial information / financial results of such subsidiary located outside India from the accounting principles generally accepted in its country to the accounting principles generally accepted in India. According to the information and explanations given to us by the management, these interim financial information / financial results are not material to the Group. Our conclusion in so far as it relates to the balances and affairs of such subsidiary located outside India, including other information, is based on the conversion adjustments prepared and certified by the management of the Parent Company.
